- +All Youth-at-Risk (YAR) classes are open to the general public.
  - +The standard fee for a 8 week series is \$75.
  - +Underlined dates designate the classes that parents are expected to attend also.
  - +Level I classes apply to 11 to 14 year olds (middle school grade level).
  - +Level II classes apply to 14 to 18 year olds (high school grade level).
  - +All families should call to check on the availability of space in the series. If space is available when they call, court funded families/teens may be allowed to reserve a space in the class due to their court funded status without paying the \$25 deposit. Regardless of whether the space in the series was reserved through a court referred status or by \$25 deposit; if the family/teen does not arrive by 4:45 pm on the day of the first class of the series, seats in the class will then be assigned on a first come-first serve basis based upon who is actually present in the waiting area at 4:45 pm.
